The only time you will not be charged is if our volunteer EMT's respond. Our volunteer squad is not part of the paid service.

POLICE DEPT

Police Chief Cantwell stated that the new police vehicle was being outfitted.

Chief Cantwell also stated that the Village PD was going to participate in the LEADS Program – Law Enforcement Assisted Diversion Program – offered by Broome County DA's office whereby the police do not prosecute individuals for minor crimes if they agree to immediate drug treatment. The eligibility is strict and a onetime deal.

STATEMENT FOR PUBLIC DISTRIBUTION

The Village of Deposit and its Police Department are pleased to announce that a law suit filed by Troy Proffitt, Dawn Proffitt, and Corey Proffitt against the Village, the Police Department and various officers is officially dismissed. The Federal District Court in this case dismissed nearly all of the claims by the Proffitts'. Those minor claims which remained have been dropped and abandoned by the Profitts' which resulted in dismissal of all claims. This action now as been fully discontinued and resolved in favor of the Village of Deposit and its officers named in the suit.

The Village of Deposit and its Police Department were fully exonerated by the dismissal and discontinuance of the law suit. The public should have full confidence that its department acted at all times lawfully and appropriately and within the bonds of the law. The Mayor stated that the Village had good liability coverage but unfortunately its cases like this that make the insurance rates increase and that affects all taxpayers. Our coverage paid the attorney's over \$45,000 to defend our department.
