Deputy Mayor McKee opened the meeting with the Pledge of Allegiance at 7:00 p.m.

PUBLIC HEARING

LL # 4 OF 2011

FLOOD DAMAGE PREVENTION

Mayor McKee opened the Public Hearing at 7:15 p.m. CT Decker explained that the amendment to LL#4 of 2008 was to include the sentence " LOMR effective 02/25/2009, FEMA case #08-02-1345P, revising FIRM Panel 0005B". LL# 7 off 2008 was adopted for the Flood Damage prevention with the completion of the LOMR map of upper Second St. At that time we did not include the above sentence. LL#4 of 2011 will encompass this sentence.

Mayor McKee asked the public if there were any comments – there being none he then asked the board for comments. There were no comments. The Mayor asked the following resolution be adopted:

RESOLUTION ADOPTING LOCAL LAW NO. 4 for 2011

WHEREAS, a resolution was duly adopted by the Village Board of Trustees of the Village of Deposit for a public hearing to be held by said Board at the Deposit Theater, Front Street, Deposit, New York at 7:15 p.m. on Tuesday, April 12, 2011 to hear all interested parties on a proposed Local Law entitled "A Local Law Amending Chapter 80

– Flood Damage Prevention – of the Code of The Village of Deposit and Amending Local Law No. 7 of 2008,” to update the references to the special flood hazard insurance rate map; and

WHEREAS, the environmental significance of the Local Law No. 4 was considered by reviewing a short-form Environmental Assessment Form (EAF) and the action was determined to be a Type II action under the New York State Environmental Quality Review Act (SEQRA), which requires no further environmental review prior to the adoption of Local Law No. 4 for 2011; and

WHEREAS, notice of said public hearing was duly advertised in the Deposit Courier, the official newspaper of the Village and posted on the Village Clerk’s Sign Board; and

WHEREAS, said public hearing was duly held at the Deposit Theater on April 12, 2011, and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, or any part thereof; and

WHEREAS, the Village Board of Trustees of the Village of Deposit, after due deliberation, finds it in the best interest of the Village to adopt said Local Law,

NOW, THEREFORE, the Village Board of Trustees of the Village of Deposit hereby adopts said Local Law as Local Law No. 4 for 2011 and the Village Clerk is directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Village of Deposit, and to file said Local Law with the Secretary of State.

Hubbard informed the board that the water dig in front of the Village Hall scheduled and then cancelled for last Thursday will take place this Thursday April 14th. The DPW has started sweeping the streets. Hubbard asked that residents bag all lawn and garden debris as this is much easier to collect. In the fall leaves can be put to the curb for collection by the leaf machine but in the spring debris should be bagged.

Hubbard explained that the Deposit Midget League would like to do clean up on April 16 and April 23 weather permitting and would like to use the Village equipment if necessary such as the back hoe or loader.
