

WORK SESSION OF THE VILLAGE BOARD OF TRUTEES ON APRIL 27, 2021 AT VILLAGE HALL 61 FRONT ST., AT 4:00 P.M.

PRESENT: Mayor Moore, Trustees Brown and Warner, C/T Budine, DC/T Shirkey, DPW Supervisor Steve Evans and CEO Hathaway.

ABSENT: Trustees Durning and Price

CEO Hathaway spoke about 125 Front St. He feels we should wait until the end of the month at least before we proceed with declaring it an unsafe building. It will depend on what the owner's Law Guardian wants to do and then what the County wants to do . There is no sense in starting only to have to restart if the County takes it. When we get to that point, we will have the lawyer write the letter and then it will proceed to a hearing with the Board. Mr. Hathaway said these things take time. Mayor Moore agreed and stated that the County Executive said it could take 2 or 3 months.

Mr. Hathaway checked the new business on Front Street and said she could have a business. Mayor Moore stated that anyone could sell their own personal things. It is zoned business district. Mayor Moore went on to say that Planning Board members should follow procedure and that one person should call the Code Enforcement Officer with questions and not come to board meetings with questions.

CEO Hathaway also mentioned that it is grass mowing season and a notice has been put in the paper. Supervisor Evans asks that residents do not mow grass into the street, it is against the law.

Mayor Moore asked how long it would take before the buildings that burned on Allen Street would be cleaned up. CEO Hathaway said that right now they were waiting on the insurance companies. After that things would be taken care of. Trustee Brown asked if it was all taped off. Mr. Hathaway said that it was.

DPW Supervisor Evans said that they would be flushing hydrants on May 3<sup>rd</sup> from 6AM – 12 noon.

Mr. Evans said that they had been repairing blacktop and filling in holes on Front St. He went on to say that the knotweed study was about to begin in Willis Smith Park.

Mr. Evans wanted to say thank you to the local NYSEG crew, for all their help. They have taken care of a tree on Main Street and it is greatly appreciated. They do a great job!
