

WORK SESSION OF THE VILLAGE OF DEPOSIT HELD ON JULY 27, 2010 AT THE DEPOSIT THEATER AT 7:00 P.M.

ABSENT- PWA Hubbard

Mayor O'Connor opened the public hearing on Local Law # 4 of 2010, amending chapter 140, off street parking.

Sharon Wright asked if this included trailer parks, Attorney Westfall stated that it did not. Deb Stever expressed concern about accessibility in trailer parks for emergency vehicles. Attorney Westfall stated that this law does not address that issue.

The Mayor closed the meeting at 7:10 PM. It was decided to hold the vote until the August 10th regular session.

OLD
STREETS

PWA Hubbard stated that the construction crew will do their best to have Second Street open for the Ice Cream Run. The catch basins and curbs were poured today.

MOTION #117/10-11

PWA Hubbard stated that well house #2 is in an emergency situation. Mr. Hubbard has been contact with Moody Pumps and they are preparing an estimate for repairs and this will be submitted to the insurance company. Because this is an emergency, Mr. Hubbard asked the board for permission to move forward with the repairs. Trustee McKee made the motion and Trustee Sollecito seconded, to all PWA Hubbard to proceed with repairs. Motion passed.

Trustee McKee made a motion for a budget amendment in the amount of \$41,068, Trustee Sollecito seconded. Motion passed unanimously.

MOTION#118/10-11

PWA Hubbard also, informed the board that the water line in Oquaga Creek was exposed and this is a huge concern, and need to be fixed as soon as possible. Mr. Hubbard has contacted the DEC and applied for all the necessary permits. He has also acquired a bid from Schaeffer Enterprises in the amount of \$2,500. Motion was made by Trustee O'Connell and seconded by Trustee Warner to get the repairs done. Motion passed unanimously.

MOTION#119/10-11

Trustee McKee made a motion to make a budget amendment for \$2500.00, and was seconded by Trustee Sollecito. Motion passed unanimously.

Mr. Hubbard informed the board that the fishing access road is being slowly eaten away by the river and should be fixed. It was decided by the board that Brad should put this ob out for bid, as it was not an emergency situation.

The Mayor initiated a discussion about the pocket park. The Mayor thought room should be made in the plans to take the Veteran's memorial. He also mentioned that we should find out if the bandstand from Rotary Park can be brought over. Trustee McKee stated that the park would be nice, but we should actively market the property. Motion was made by Trustee O'Connell and seconded by Trustee Sollecito to authorize the Mayor's signature on the Shumaker proposal.

Attorney Westfall brought everyone up to speed on the IDA lines. She will get the draft of the assignment of IDA lines together and off to Glenn Nealis for his signature.

Ms. Westfall also brought the board up to speed on the parking and traffic violations revisions. If we choose to amend our local laws, we can receive roughly the first \$8,000, with the rest going to the State.

The Mayor also, suggested that we start to think about what we will do if Broome County pulls out the recycling bin, next year.
