STREETS

Davie is looking for ribbon style guiderails to replace the ones on Pine St. He also has DOT looking for us.

Next, Davie asked about the Brm Cty auction. He has some tires, an old salter, etc. The board said they would rather he used Auction International for his equipment. The board asked Davie to bring a list of the equipment he wanted to auction off at the next meeting and we will declare it surplus. Next the board asked about the snow blower that sits at the WWTP. Davie said he'd see what it might fit.

BUILDINGS

Davie stated that he would like to advertise the lights that were removed from the fire hall as a lot in "as in" condition in order to get rid of them. Davie also informed the board that the boilers at the Fire Hall were fixed and were working just fine. Davie informed the board that the water used to water the football field is not being metered. Davie then informed the board that there was a company that may want to buy water from us from the pipeline and also possibly return that water to the plant.
