# PUBLIC HEARING LOCAL LAW #5 PUBLIC WORKS ADMINISTRATION FEE 7:00 P.M.

President O'Connor opened the public hearing at 7:00 p.m. O'Connor explained this local law would add a \$50 admin fee whenever the public works department has to perform a service that protects the health and welfare to enforce a local law – such as grass cutting, snow removal and refuse removal which is charged to the property owner and relevied if they don't pay in 30 days.

Sharon Wright asked if the haulers would have to go to bid. O'Connor stated no, it was not subject to the bidding process. Wright asked if tenants left trash would the homeowner be responsible? O'Connor stated yes that the homeowner is always responsible for their property. Wright wanted to know the time frame from code enforcement notice to hauling away. O'Connor stated he didn't know the time frame – that had nothing to do with the Local Law adding a fee for the administration of the violation.
