PRESENT: Mayor Moore, Trustees Durning, O'Connor, Warner and Strauss, C/T Budine, DC/T Shirkey, DPW Supervisor Steve Evans, Fire Chief Rynearson and Mike Musante.

Mayor Moore led everyone in the Pledge of Allegiance.

The Mayor opened the Public Hearing on LL#1 changing the definition of "Domestic Animals" in Chapter 140 Zoning.

Trustee O'Connor felt that the law banned cats and dogs from all areas that are not zoned agriculture. CT Budine explained that the law defines Domestic Animals as the keeping of more than 5 cats, more than 5 dogs; or any number of horses, cattle, pigeons, fowl, rabbits, sheep, goats, pigs or other customary farm animals; or beehives; or animals customarily kept in zoos; or the keeping of any animals for sale or hire, except for the sale of animals in commercial pet shops. An amount of dogs or cats under five are not defined as "Domestic Animals" and therefore allowable in areas that are not zoned agriculture.

Mayor Moore closed the hearing.

At a meeting of the Village Board of the Village of Deposit, held at Village Hall, 61 Front Street, Deposit, New York on the 12th day of December, 2023, the following resolution was offered and seconded:

WHEREAS, the Village Board of the Village of Deposit scheduled a public hearing for December 12, 2023 at 7:00 p.m. for Local Law No. 1 of the year 2023, entitled "A Local Law Amending Section 140-4 Regarding the Definition of Domestic Animal"; and

WHEREAS, notice of said public hearing was duly advertised in the official newspaper of the Village, and posted on the Village Clerk's sign board; and

WHEREAS, the Local Law was referred to the Village Planning Board and the Planning Board has issued a recommendation thereon; and

WHEREAS, the Local Law was referred to the Delaware County Planning Department pursuant to GML § 239-m and the Planning Department has issued a recommendation thereon; and

WHEREAS, said public hearing was duly held at Village Hall, 61 Front Street, Deposit, New York on 12th day of December, 2023 at 7:00 p.m. and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, or any part thereof; and

WHEREAS, pursuant to Part 617 of the implementing regulations of the State Environmental Quality Review Act, it is determined by the Village Board that adoption of the proposed Local Law constitutes an Unlisted Action, as defined under said regulations. The Village Board has considered the possible environmental impacts of the Local Law. The adoption of said Local Law will not have a significant adverse impact on the environment and the Village Board adopts a negative declaration with respect to the Local Law; and

WHEREAS, the Village Board, after due deliberation, finds it in the best interest of the Village to adopt said Local Law.

NOW, THEREFORE, **BE IT RESOLVED** that the Village Board hereby adopts said local law as Local Law No. 1 of 2023 entitled "A Local Law Amending Section 140-4 Regarding the Definition of Domestic Animal", a copy of which is attached hereto and made a part hereof; and

BE IT FURTHER RESOLVED the Village Clerk be and hereby is directed to enter said Local Law in the minutes of this meeting and to give due notice of the adoption of said Local Law to the Secretary of State; and

BE IT FURTHER RESOLVED that this resolution will take effect immediately upon filing with the Department of State.

FIRE DEPARTMENT

Fire Chief Rynearson stated that the air bottles are on engine 211, next year more will be ordered. The fire trucks will be inspected this week. The inspection dinner will be at the Fire Station this year.

TRUSTEES

PRESIDENT

Mayor Moore spoke about an article Trustee O'Connor gave him regarding the uptick of ATV's on public roads. It appears to be happening all over and is not such a new problem. The Board felt that as more tickets are handed out for this the incidents of this will decrease.

The Mayor stated if the Board was ok he would sign the BC Shared services agreement for 2024.

Mayor Moore stated he needed a moment in Executive Session.

Mayor Moore went on to inform everyone that he has started to think about the steps to make the Village all Broome County. He asked the Board to please consider the pros and cons of such a move. This was prompted by the n2024-25 General Fund Budget. The tax rates are severely affected by the amount of sales tax we get from Broome County. This will result in Broome County side of the Village, taxes going down and Delaware County side of the Village, taxes increasing. He would like to have the taxpayers weigh in on how they feel about this and will contact the newspaper to get some announcements done.

Mayor Moore asked if the Board had looked at the letters from Keystone regarding the road use agreement with Bluestone Wind. Supervisor Evans has obtained a quote for repair of the damage done to Allen Street.

He updated the Board on the sale of 125 Front Street and 5 Church Street.

He also will instruct the lawyer on the next steps for the unsafe building on Front Street.
