

REGULAR SESSION OF THE VILLAGE BOARD OF TRUSTEES ON DECEMBER 13, 2005 AT 7:00 P.M. AT MEADOW PARK COMMUNITY CENTER.

MOTION #250/05/06

A motion was made by Trustee O'Connor seconded by Trustee Nolan to enter into and out of Executive Session. The Motion carried unanimously.

OLD BUSINESS

Streets

PWA Hubbard informed the board that the Village Crew had performed 58 work orders for the Village and 26 for the OLWWTP.

MOTION#257/05-06

A motion was made by Trustee O'Connor seconded by Trustee Axtell-Whiting to charge \$50.00 an hour for snow removal. The motion carried unanimously.

Trustee Nolan supports this motion but wanted it on record that there are some store front properties on Front St. that should be done immediately because they are in the business district.

MOTION#258/05-06

A motion was made by Trustee Axtell-Whiting seconded by Trustee O'Connor to authorize the Mayor's signature on the Town of Deposit Water District Agreement. The motion carried unanimously.

Trustee O'Connor and PWA Hubbard wanted to thank the Town of Deposit for their help with grading the ditches from Deposit Pre-School to the bottom of the hill on Columbia Lake Rd. with providing a grader and an operator. Their help was much appreciated.

Sewer:

PWA Hubbard informed the board that Shamrock Video will be in this Thursday at noon (Dec. 15, 2005) to camera the two priority spots and the tapes will go directly to Stearns and Wheler. At that time S&W will find a contractor and those major leaks will be fixed.

Buildings:

PWA Hubbard informed the board that he had received an estimate from Shumaker Engineers on the engineering and probable construction costs for the fire escape at the back of the Village Hall. The total estimated cost is approximately \$30,000 with \$8,400 of that being engineering costs.

PWA Hubbard wanted to remind the board that the Village had 60 days to award the bid on the Assembly Hall demolition.

Fire Dept.

President Smith informed the Board that C/T Decker had contacted Suzanne Etherington of the NYS Records Retention and the Fire Dept and EMS records fall under the same laws as the Village. The assembly hall records will have to be gone thru and either photocopied by taking proper precautions or special permission asked of the state to destroy them.

NEW BUSINESS

President Smith informed the board that the \$900,000 FAB grant was denied. Julie Sweet our Economic Director is going to write for an explanation.

Fire Dept.

Trustee Nolan informed the board that the Fire Dept. had turned in the training on LP Gas. Training was one of the eight points that the board had with the fire dept.

3. This resolution shall take effect immediately.

GUESTS:

Ray O'Dell thought we were having another Zoning Public Hearing. President Smith stated that we would be having another hearing, but not tonight.

Liz Medansky – She stated that she was upset about what had been written in the newspaper about EMS Training. She felt she should have been consulted if the Village Board had any questions about the training of the Fire Dept, EMS Squad. She stated that the newspaper read as if the training was substandard. President Smith stated that the actual training was never in question – what the board had questioned was receiving records of who has attended training and what the training is for etc. Ms. Medansky stated that she felt the EMS had some of the best training in the County and just b/c we don't pay for it does not make it substandard. President Smith stated again that the Village Board had no issue with the actual training.

EMS Captain Randy Hartz stated that in an effort for crowd control, he would appreciate it if all would hold their questions and comments at this time.

Mary Cable wanted to thank the girls in the front office for the wonderful way they were treated during the special election.

Larry Schaefer was present to show his support for the EMS and Fire Dept. He also wanted to thank them for all they have done in the past. He asked that all

the facts be considered when making a decision on the residency requirements. He also stated that he thought the bids on the demolition of the assembly hall needed to be looked at more closely. They did not seem accurate. There was too big a margin between the lowest and the highest bid.

Wilber Dennis wanted to publicly thank the Village Crew for a good job done during the latest snow storm.

Pete McDade was present to show support for the EMS and Fire Dept. as well. Mr. McDade stated maybe he should volunteer for the snow removal at \$50 and hour. President Smith stated that the Village was not in the snow removal business and home owners needed to be responsible for their walks and they would not be charged the \$50 an hour fee.

Deb Ditewig stated that she was in support of the EMS and Fire Dept. She apologized for not attending any of the meetings. She wanted to know what the whole point of the residency requirement was and who brought it to our attention. President Smith stated he wasn't at liberty to reveal that information but that we had researched and the residency requirement was the result of that research. Ms. Ditewig stated that laws are made to be changed and we should change some of the antiquated laws. President Smith stated that as soon as the attorney's have had their talks we would know more. Now that the attorneys were involved, we could not discuss any further.
