BE IT FURTHER RESOLVED, that the Project, including the receipt of the CDBG, is an Unlisted Action pursuant to the New York State Environmental Quality Review Act (SEQRA) regulations 6 NYCRR Part 617.2(ak); and

BE IT FURTHER RESOLVED, that the Board of Trustees of the Village of Deposit hereby declares itself the lead agency for SEQRA review and notification of lead agency status will be provided to all involved agencies.
