The Mayor opened the meeting at 7:00 p.m. with a Public Hearing on the CFA application as follows:

# PUBLIC HEARING 7:00 p.m. 2017 CFA Application

The Mayor opened the Public Hearing at 7:02 p.m. He summarized the tentative 2017 Consolidated Funding Application (CFA) of \$756,000 to repair aeration tank #1 and #2 and the clarifier tank. The Village has an engineering report from Watson Engineers recommending the repair of the tanks with a lining system for interior walls and a base protection along with the exterior walls with concrete and steel replacement techniques. The tanks are in various levels of degradation. The clarifier is showing signs of partial loss of cement binder along with rust and corrosion along the surface where there are visual signs of the coating breaking down. This project would provide the much needed upgrade to the tanks. The Mayor asked if there were any questions from the public. There were none. The Mayor then asked if the board had any questions. There were none. The Public Hearing was closed at 7:02 p.m.

RESOLUTION INTRODUCED BY THE VILLAGE BOARD OF DEPOSIT, NY AUTHORIZING A CONSOLIDATED FUNDING APPLICATION (CFA) AS A SPONSOR/APPLICANT FOR NYSOCR CDBG FUNDING UP TO \$750,000 THROUGH THE CDBG PUBLIC INFRASTRUCTURE PROGRAM FOR IMPROVEMENTS TO THE VILLAGE WATER AND SEWER INFRASTRUCTURE AND SIDEWALKS

**WHEREAS**, the Village of Deposit held a public hearing on June 27, 2017 wherein it notified the public of its intent to apply for NYSHCR CDBG funding to upgrade its water and sewer infrastructure and to also seek funding for sidewalk improvements; and

WHEREAS, the funding sought through the CDBG Program relates directly to the engineering work and subsequent construction of water, sewer drainage and sidewalk improvements; and

**WHEREAS,** the project would address safety, health and security concerns related to the deteriorated infrastructure; and

**WHEREAS**, the project would include ancillary public works activities such as the replacement of sidewalks to improve ADA accessibility, pedestrian safety and convenience; and

**NOW, THEREFORE, BE IT RESOLVED,** the Village Board of Deposit does hereby authorize Alan J. Sorensen, AICP of Planit Main Street, Inc., to prepare and submit said CFA Program Application on behalf of the Village of Deposit; and

**FURTHERMORE BE IT RESOLVED**, the Village of Deposit shall enter into a formal agreement with the NYS Homes and Community Renewal, and adhere to the timeframes and scope of work outlined in such agreements if funded; and

**FURTHERMORE BE IT RESOLVED**, that the Village will accept responsibility for the project development in accordance with State requirements.
