REGULAR SESSION MEETING OF THE VILLAGE OF DEPOSIT BOARD OF TRUSTEES HELD ON JULY 8, 2003 AT 7:00 P.M. AT MEADOWPARK COMMUNITY CENTER.

President Hayes opened the meeting with the Pledge of Allegiance at 7:00 p.m.

#### PUBLIC HEARING 7:00 P.M.

Local Law amending Chapter 61 entitled "Brush, Grass and Weeds" of the Code of the Village of Deposit. Section 61-2 is adjusted to allow for a 72 hour time period for the fine to begin. Section 61-4 is adjusted to address the service of notice. Notice is complete upon the mailing and posting of the violation. In the past we had to wait to receive the green signed certified card before beginning the in violation process. There was much discussion on the property owner receiving the notice, how does the Village know the homeowner has received notice and where does the Village mail such notice? The notice is mailed first class mail to the last known address of the owner. Once mailed the Village considers the notice served. Administrator Hubbard informed the public that if, after notice, the Village mows, they also weed whack and trim anything needed to make the property presentable.

Local Law amending Chapter 125 entitled "Vehicle and Traffic" of the Code of the Village of Deposit. This amendment would allow a four-way stop intersection at Wheeler and Dean St. Trustee Edwards informed the board of the need for the stop sign as this is the school cross walk and people entering town from Big Hollow do not slow down.

Local Law amending Chapter 113 entitled "Streets and Sidewalks", of the Code of the Village of Deposit. This amendment allows for the same notice of service as the Unsafe Buildings law did. It gives the Village a better time frame in removing snow and ice in the winter.

Local Law repealing the unsafe buildings local law 1-2000 and re-enacting same as Chapter 123 entitled "Unsafe Buildings" of the code of the Village of Deposit. taking out the inspection via the warrant paragraph that occurs under the section of inspections. It will no longer be necessary for a warrant to be issued to find probable cause.

The public hearings were closed at 7:30 p.m. President Hayes thanked Bertha Jenson for the flowers in the front of the Village Hall.

#### Guests:

Jim Jones stated the paving projects in the Village was lacking. Administrator Hubbard informed the board that he has been working with Shumaker Engineers on streets to be paved this year. The Village is tentatively planning on Pine St. from the caution light to the red light, Second St. from the County line to the red light, Dean St. from Center to Pine, and Dean St. from Front to Second.

Bertha Jenson commented that she thought Brad Hubbard, our new PW Administrator, was doing an excellent job. Bertha also commented on business done in executive session or our monthly work sessions should be reported to the taxpayers in a more responsible manner.

Trustee Edwards stated that he would like everyone to know that at no time has he not supported the Fire Dept. He believes the fire dept has done an excellent job.

#### **NEW BUSINESS:**

#### STREETS:

Administrator Hubbard stated that Cook's Tree Service will be in the Village on July 22, 2003 to remove eight trees. They will remove stumps, limbs, wood chips. TDS Telecom has agreed to pay 1/3 of the cost, a proposal has been faxed to NYSEG and we are awaiting their response.

Mr. Hubbard also stated that the 1995 Backhoe needs a set of front tires. A quote from County Tire in Delhi was 8 ply 12X16.5 for \$95.64 and 10 ply 12X16.5 for \$127.66 for both tires.

#### MOTION 199/03-04

A motion was made by Trustee Smith seconded by Trustee Maasch to purchase 2 12X16.5 backhoe tires @ \$127.66. The motion carried unanimously.

Next, a discussion took place on the new drive way placed on upper Court St. The drainage is a severe problem as it washes gravel all down Court St. President Hayes stated that Broome County gave the permit for the driveway. Mr. Hubbard was instructed to contact Broome County and get back to the board.

## WATER:

Mr. Hubbard informed the board that pump house #4 has a noise in the motor and is caused by a crack in the packing around the housing.

#### SEWER:

President Hayes informed the board that the signing of the consent order has been postponed because of the location of the ADA site for handicapped access to Oquaga Creek. The Fire Dept., Trout Unlimited, and the DEC put in a handicapped fishing area and it was damaged by a major flood. The Village proposed to repair that site in lieu of the fine from the consent order. The DEC will meet with Shumaker Engineer and the Village to revisit the proposed site on Thursday July 10<sup>th</sup>, 2003.

President Hayes then asked for approval for his signature on the Allardice Bond Counsel Contract. The contract is in three parts, the first part being \$2,600.for the Bond Anticipation, \$5,200 for the Revolving Fund Application and \$5,500 for the sale of the bonds. The first expenditure is the \$2,600.

President Hayes also informed the board that a letter had been taken to the Fire Dept. Inc. asking permission to rebuild the fishing access and received approval.

#### MOTION #200/03-04

A motion was made by Trustee Smith seconded by Trustee Maasch accepting the contract with Allardice Assoc. and approving President Hayes's signature. The motion carried unanimously.

President Hayes asked the board for permission to have the PW Dept. pick up some office furniture from the Mayor's office in Johnson City for Mr. Hubbard's office and the Code Enforcement Office.

STREETS: Loader tires that the Village ordered is in and Administrator Hubbard will make arrangements to pick tires up Thurs. or Fri. The DPW is also waiting for estimates from Vestal Asphalt for the street paving projects.

SEWER: The pump purchase and relay was made after contacting three of the four board members for approval. Administrator Hubbard suggested to the board that when the new pump is installed; the Village should repair the old pump for use elsewhere if needed. Quotes were at approximately \$1500.00. The Board instructed Mr. Hubbard to see where the rebuilt pump can be used and report back to the board.

Mr. Hubbard also stated that Shumaker Engineering was going to get bid specs to us about the generator at the sewer plant. Shumaker will be receiving bids no later than July 11, 2003 and will then be forwarded to the Village for determination.

President Hayes asked for a motion from the board to accept the proposal from Life Safety for the inspections of the Areas of Public Assembly at \$50 per site inspected at an approximate cost of \$800.00.
