Trustee Mott informed the board that he had a proposal from Chief Cantwell for in car cameras. The WatchGuard system is a Rockland County Bid that we can piggyback. Mott explained that each unit has three cameras; one camera facing the front that can move side to side; the second camera also faces the front which covers 160 degrees in front; the third camera is located in the rear compartment of the car. The microphone for these cameras is worn by the officer and is voice activated. There is a feature to have it record all the time as well. The PD would like to purchase three cameras at a total cost of \$16,047 with \$2,400.00 coming from A3120.2 and the balance coming from the PD reserve. The board agreed to table this request. Further they would like to see quotes for body cameras as well.

## NEW/OLD BUSINESS

Supervisor Davie stated he was fixing potholes as manpower allowed. He informed the board that the foam insulation is coming off the fire station interior roof and needs repairs. Supervisor Davie gave the board the three quotes he received for the trucks as follows:

Next Supervisor Davie gave the Board his estimates on the street paving. He wants to pave parts of Front, Dean, Pine and River with the annual CHIPS money. After some discussion, it was determined that River St. would not be done this year and another street would be added for final approval at the work session.

Supervisor Davie then informed the board of Shumaker Engineers suggested resolution for the Fair St. drainage problem. The Village has asked Shumaker for a cost estimate to repair the problem.

## MOTION#145/15-16

A motion was made by Trustee Hathaway seconded by Trustee Strauss to allow the topkick to be repaired by Franks Garage as per the quote of \$4,101.00. The motion carried unanimously.

Trustee Mott asked Supervisor Davie how many trucks were actually needed by the DPW? Mr. Davie stated that each man plowed – so 5 or 6 plus the topkick.

Supervisor Davie then had some discussion with the board on the upcoming Streetscape project and plastic vs. copper for the water laterals. The board agreed plastic was cheaper and just as good. Davie also inquired as to mole hole laterals vs. open sidewalk. If we go to the face of the buildings then open sidewalks would be the only way to hook up. If we mole hole then we must punch through the building to the meter inside. Trustee Mott stated he had discussed this with the engineer and the engineer said that is contractor issue. We will need to look at the plans and talk with the contractor about this.

Davie also brought to the attention of the board that the Village is buying 3 gallons of degreaser a week at \$90 per gallon for Meadowpark and the Chinese Rest. Davie felt that if other businesses take care of their grease these businesses should as well. C/T Decker said she would get a copy of the code to the board.
