

THE WORK SESSION OF THE VILLAGE BOARD OF TRUTEES ON MARCH 28, 2023  
AT VILLAGE HALL 61 FRONT ST., AT 4:30 P.M.

PRESENT: Mayor Moore, Trustee Strauss Durning, O'Connor and Strauss, C/T Budine, DC/T Shirkey, DPW Supervisor Steve Evans, CEO Pete Hathaway, Mary McFadden Broome County and Bridget Davis.

ABSENT: Trustees Warner

Mary McFadden gave the State of the County report.

Mayor Moore asked Ms. McFadden to tell BC Executive Jason Garner about our loss of the Deposit Foundations transportation program and the very real need of Deposit's Senior Citizen's need to get to important appointments. Ms. McFadden said that she would certainly tell him.

DPW Supervisor Evans wanted to thank Broome County for their work on the Second Street drainage project.

STREETS, WATER, SEWER

Supervisor Evans reported that the DPW was cleaning things up and getting ready for Spring. Brush pickup will begin April 3 and continue on the first and third Mondays of the month. All lawn debris must be in biodegradable bags or a container that the crew can dump out into our truck. Debris and branches must be small yard debris.

FIRE DEPARTMENT

Chris Zacharias reported that the Ladder test will be done on April 10<sup>th</sup>. Things are running well. There was a small fire on Elm Street but it was quickly taken care of. Trustee O'Connor asked about the Certificate of Need. Mr. Zacharias stated that the Delaware County side still needs to be done.
